

## TYLER HICKS SCHOLARSHIP FORM 2026

This is open to June 2026 high school graduates from Scott County Schools (Scott County High School and Great Crossing High School), only, where Tyler Hicks received his education. Deadline for submission to your counselor is April 15, 2026.

### CRITERIA

- Must be a Scott County High School Senior or Great Crossing High School Senior on track to graduate in the spring.
- Must be on track to graduate with a cumulative GPA of 2.0 or better
- Must have demonstrated outstanding leadership qualities
- Must have exhibited the skills to be a great teammate
- Must have demonstrated a strong work ethic in the classroom & athletic field
- Must exhibit a financial need for assistance to continue education
- Must be an athlete or member of athletic support staff, in good standing, to be eligible

**This scholarship is for \$10,000, for a 4-year college education to be disbursed in 8 equal amounts - \$1,250 per semester (\$2,500 per year). It is automatically renewable if the following conditions are met:**

- Must be in good standing @ one's chosen school. Proof must be provided from the Admissions office.
- Must maintain a GPA of 2.0 or better. Must provide copy of transcript from the registrar's office to renew scholarship
- Must be a full time student (\_\_\_\_\_ hours/semester)
- Must be on course to graduate

All scholarship proceeds will be paid directly to the school in the name of the recipient.
